

A Housing Crisis, not an immigration crisis!

There are racist narratives being spread around the on-going housing crisis and conflating the issue with migrants, especially blaming international students!



Scapegoating migrants and blaming them for socio-economic issues in a country has been a long time false and racist rhetoric used by governments to cover up the systematic failures of capitalism.



International students renting in Canada often experience all kinds of abuse when trying to find housing. This abuse includes price gouging, invasion of privacy, sexual harassment, assault, exploitation and illegally low living standards.

CRAB Park Update: In the past few days, the City of Vancouver and Vancouver Park Board have been destroying the CRAB Park Tent City. Displacing people from their homes.





An Open Letter in Support of the CRAB Park Tent City *signatures as of 9am March 22nd

x*ma8k*ayom, skwxwú7mesh & salilwatat lands: This letter is in support of the CRAB Park Tent City and in opposition to the City of Vancouver and the Vancouver Park Board's plans to bring the CRAB Park Tent City to an end using force and deception.

If the City of Vancouver goes forward with their plans, the CRAB Park Tent City in its current form will be destroyed. It will be replaced by a city and non-profit managed tent city in which no new residents will be allowed in to live. Instead, Park Rangers, backed by the VPD, will determine who is allowed to live in the tent city based on who they assert is currently living there [Appendix A].

This level of control and surveillance will restrict new and returning residents from finding a safe home in CRAB Park, ultimately pushing everyone out. This is also why all structures in the current tent city are being destroyed as part of this "cleanup" - to push people out.

And while the City is adamant "this is not a decampment", there are emails dated July 4, 2023 that the City, Park Board and Province have been coordinating on "resolving CRAB Park" [Appendix B] for

This is a decampment. People's homes and communal spaces are being destroyed. This is why the First Nations Leadership Council also opposes the Parks Boards plans saving there are "nothing other than a forced eviction," And all of this is occurring while the CRAB Park residents have a case before the BC Human Rights Tribunal about the Park Board's failure to provide "basic survival services."

The City is citing "serious health and safety concerns" to justify the destruction of the homes of unhoused people. Despite this, Vancouver Coastal Health has confirmed that there is no Public Health Order calling for this "cleanup" (Appendix Ct. Health and safety in tent cities is complex. While residents agree and want the tent city to be healthier and safer - and out in hours of work to make this happen -destroying their homes will make people less safe and less healthy.

Residents should be given the cleaning and maintenance materials they are asking for so, they can clean their community safely and respectfully instead of having to face this assault on their homes.

We believe that the City of Vancouver is calling its plan a "cleanup" as it creates an easy and sympathetic narrative to disguise what will be a slow, coercive and many week long decampment. They are worried about public relations as opposed to respecting the rights of unhoused people.

A key recommendation from the Federal Housing Advocate's recently released report Upholding Dignity and Human Rights is that: "People living in encampments must play a leading role in decision-making processes that affect them."

The residents of CRAB Park have not played a leading role in the decision making process around this "cleanup".

By the end of day Sunday, March 24, all residents must be out of the "Designated Area" so city crews can finish destroying every home there. These are the same crews who are actively in charge of street sweeps across so-called Vancouver.

If they had: there would be no mass eviction of residents from the Tent City: no structures would be destroyed: residents would be paid as peers to do the cleanup themselves; a detailed plan of the "cleanup" would have been given to residents and signed by all parties (an idea proposed by residents, to which the Park Board responded "we disagree"). All of this and more of the resident's wishes for this "cleanup" can be found on pages 34 through 47 of the City's "Confirmed Plan" document [Appendix D].

It is also important to note that the Confirmed Plan states that if a resident refuses to leave their home in the CRAB Park Tent City "then they may need to be escorted out of the designated area by VPD." Police power is not required for cleaning. It is required to displace people by force from their homes when they are unwilling to leave. That is a decampment.

We call for the City of Vancouver and the Vancouver Park Board to:


- 1. Halt the decampment;
- 2. Allow residents to lead and orchestrate a cleanup themselves;
- 3. To have a written plan that will be signed by residents:
- 4. Not force anyone to move from their homes in CRAB Park. This means no VPD:
- 5. Not force people to put their belongings in storage:
- 6. To destroy no structures in CRAB Park:
- 7. To allow unhoused people seeking a safe place to setup a home to stay in the CRAB Park Tent City, regardless of whether they are currently living there or not.

We know that the April 5th 2023 decampment of the Hastings Tent City cost at least \$548,000.

While it is unknown how much the destruction of the CRAB Park Tent City will cost, it is our belief that whatever money is being spent on destroying a community would be far better spent on helping build community.
